The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems.

My responsibility as a Scrutinizer was restricted to scrutinize the e-voting process, in a fair and transparent manner and to prepare a Scrutinizer's Report of the votes cast in favour and against the resolution stated in the Notice. My report is based on verification of data and reports generated from the voting system provided by National Securities Depository Limited ("NSDL"), the Agency authorized under the Rules and engaged by the Company to provide e-voting facility.

The Members of the Company as on the "cut-off" date as set out in the Notice i.e. Friday March 10, 2023 were entitled to vote on the resolution set out in the Notice and their voting rights were in proportion to their shareholding in the paid-up equity share capital of the Company as on the cut-off date.

The remote e-voting commenced on 09.00 a.m. on Tuesday, March 21, 2023 onwards till 05.00 p.m. on Wednesday, April 19, 2023.

The votes cast during the remote e-voting were unblocked on **Wednesday**, **April 19**, **2023** around 05:27 pm after the conclusion of e-voting period for Postal Ballot in the presence of two witnesses who are not in the employment of the Company.
